A. CALL MEETING TO ORDER

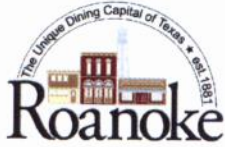
The meeting was called to order at 6:30 p.m.

Motion carried unanimously.



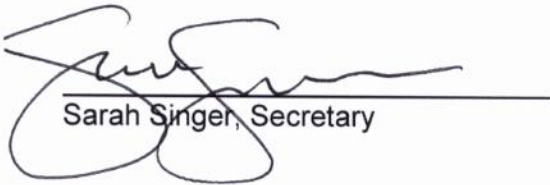
